The following draft of rules further to amend the Rajasthan Shops and Commercial Establishment Rules, 1959, which the State Government proposes to make, in exercise of the powers conferred by section 40 of the Rajasthan Shops and Commercial Establishment Act, 1958 (Rajasthan Act 31 of 1958), is hereby published as required by sub-section (4) of the said section for the information of the persons likely to be affected thereby and a notice is hereby given that the said draft will be taken into consideration by the State Government on or after the expiry of thirty days from the date of publication of this notification in the official Gazette.

Such objections or suggestions with respect to the said draft should be addressed to the Additional Labour Commissioner cum Joint Secretary to the Government, Labour Department, Shanti Nagar, Hasanpura, Jaipur.

1. **Short title & commencement.**- (i) These rules may be called the Rajasthan Shops and Commercial Establishment (Amendment) Rules, 2019.
(ii) They shall come into force from the date of their final publication in the official gazette.
2. **Amendment of rule 3.**- The existing table of rule-3 of the Rajasthan Shops and Commercial Establishment Rules, 1959, hereinafter referred to the said rules shall be substituted by the following table, namely:-

S.No.	Maximum Number of employees employed on any day	Amount of Fees in Rs.
1.	0-10 employees	5000/-
2.	11 to 50 employees	20000/-
3.	51 to 100 employees	50000/-
4.	101 & above employees	150000/-

Amendment of rule 4.- (i) The existing sub-rule (2) of rule 4 of the said rules shall be deleted.

(ii) In sub-rule (3) of rule 4 the word "return" shall be substituted by the word "statement" and the expression "under clause (1) and (2) in rule 3" shall be deleted.

Amendment of rule 6.- The existing rule 6 of the said rules shall be deleted.

Amendment of rule 8.- The existing expression "rule 6" shall be substituted by "rule 5" and the expression "for the unexpired portion of the original certificate" shall be deleted.

Amendment of rule 10.- (1) The existing word "renewals" in sub-rule (1) of rule 10 shall be deleted.


(2) The existing expression ",renewal" in Sub-rule (2) of Rule 10 shall be deleted.
